

## Community Collection Events | 2019-2020

### Community group participation requirements and step-by-step process

1. Complete a separate application for each event or project and return it to your coalition. Your event or project must take place between August 1, 2019 and June 1, 2020.
  - a. Drop-box requests: Apply at least two months before event date.
  - b. All other clean-up events: Apply at least one month prior to your event date.
2. Coalition staff will review your application within 5 days. Application approval will include the amount of approved funding for your event.
3. After application approval, you will receive the first half of the approved amount by check in approximately 30 days. Use the funds only for items included in your approved application budget. If you are unsure if an item qualifies, ask your coalition contact *before* purchase.
4. Contact any event partners as soon as possible after approval. See the Resource Guide for suggestions. This includes:
  - a. Community organizations that will assist with collection.
  - b. One of the eight approved garbage and recycling companies to secure drop boxes if you're organizing a waste collection event.
5. Provide the coalition with all promotional materials created for your event. These must include a BPS logo and a Metro logo.
6. Request any needed volunteer assistance from Master Recyclers at [www.masterrecycler.org](http://www.masterrecycler.org).
7. Get requested supplies. We ask that items be borrowed or rented whenever possible.
8. Keep all your receipts for required reporting purposes. *Taking pictures of receipts is a great way to keep records of your expenses.*
9. Have your event or host your project.
10. Complete the online report form:
  - a. Collection Report [www.bit.ly/ccecollection19-20](http://www.bit.ly/ccecollection19-20)
  - b. Litter Report [www.bit.ly/ccelitter19-20](http://www.bit.ly/ccelitter19-20)
11. Email or drop off all receipts to your coalition contact within two weeks of event completion.
12. You will receive the remainder of your approved funding amount after your group completes all the steps listed above.

## Tips to maximize funding

Each District Coalition Office has access to a limited number of drop boxes. Groups wanting to host large bulky waste events are encouraged to meet and strategize together, forming partnerships whenever possible. Brainstorm different types of innovative projects and tap into other community events to maximize the impact of your event. District Coalition staff can also help connect groups to other grant funding opportunities.

Connect with the Portland area resources below for reuse, donation and proper disposal of materials throughout the year. Call in advance to work with or donate items to any of these organizations.

## Program restrictions

The following items are **not eligible** for CCE funding:

- Giveaways such as t-shirts, hats, bags.
- Direct mail and postage.
- Equipment and supplies not pre-approved by your coalition representative.
- Alcohol.

These materials are prohibited from collection at events. To the extent possible, include restricted items in promotional materials to ensure the community adheres to event guidelines.

## Prohibited items include:

- Hazardous waste (batteries, paint, chemicals, CFLs).
- Construction, demolition and remodeling debris, e.g., roofing and asbestos-containing materials.
- Residential yard debris and trimmings.
- Commercial landscaping.
- Vehicles.
- Liquids.
- Waste and recyclables collected curbside.

## Drop boxes for waste collection events

Groups must work with the approved drop box companies listed below and must get pre-approval from their coalition for the number of boxes at their event. Call one of the following companies to reserve your approved number of drop boxes. Given the limited number of boxes available per company, you may need to call more than one.



*Drop boxes must be reserved with one of the eight approved garbage and recycling companies. A limited number of boxes are available. The cost is \$500 per drop box, no matter how full it is. Pre-approval from your District Coalition is required.*

Free Oregon statewide collection program for certain electronics. Computer peripherals (keyboards, mice) are also accepted. *Some restrictions apply.*

*Prohibited materials at transfer stations:* All construction, remodeling and demolition debris is prohibited at collection events. If an attendee brings construction debris, they should check the suspect material list (below\*\*) to see if they need to have any items tested for asbestos *before they take them to the transfer station.*

*\*\*Examples of high-risk materials suspected of containing asbestos:*

- **Flooring:** vinyl tiles, vinyl sheet, cove base.
- **Walls:** plaster, decorative plaster, textured surfaces on drywall.
- **Siding:** cement siding shingles “Transite”, stucco.
- **Insulation:** spray-applied, blown-in, vermiculite, pipe, HVAC and lagging.
- **Ceilings:** acoustical tiles, “popcorn” and spray-on texture.
- **Electrical:** wire insulation, panel partitions.
- **Other:** mastic, window glazing, fire doors, fire brick, fire proofing.
